TREC REVISED ADVERTISING RULES MAY 2019

REALTOR® MEANS = MEMBER

WHAT IS AN AD?

ANY FORM OF
COMMUNICATION BY OR
ON BEHALF OF A
LICENSE HOLDER
DESIGNED TO ATTRACT
THE PUBLIC TO USE REAL
ESTATE BROKERAGE
SERVICES.

EXAMPLES:

- PUBLICATIONS
- BUSINESS CARDS
- ELECTRONIC MEDIA
- SIGNS, BILLBOARDS, CAR WRAPS/DECALS

WHAT DO MY ADS HAVE TO SAY?

LICENSE HOLDER'S NAME OR TEAM NAME BROKER'S NAME IN AT LEAST HALF THE SIZE OF LARGEST CONTACT INFORMATION ON THE AD.

CAN I USE REALTOR® IN MY ADS?

YES! ONLY MEMBERS OF THE
NATIONAL ASSOCATION OF REALTORS®
MAY USE THE TERM AND ONLY IN CONNECTION
WITH A PERSONAL OR FIRM NAME, CANNOT BE
USED WITH A TEAM.

HOW DO I REGISTER MY TEAM NAME WITH TREC?

USE THE FORM: NOTICE OF TEAM NAME FOR A BROKER'S LICENSE, IS AVAILABLE ON TREC'S WEBSITE.

CAN I USE ANY NAME AS A TEAM NAME?

NO! TEAM NAMES MUST END WITH "TEAM" OR "GROUP" AND CANNOT CONTAIN TERMS THAT IMPLY THE TEAM IS OFFERING BROKERAGE SERVICES INDEPENDENT OF THE BROKER.

CAN I USE A NICKNAME, MIDDLE NAME OR ALTERNATE NAME IN MY ADS?

YES! THE NAME MUST BE REGISTERED WITH TREC BY USING THE FORM: NOTICE OF ALTERNATE NAME USED BY A SALES AGENT OR BROKER LICENSE.



DO THESE EXAMPLES COMPLY WITH THE LAW AND THE CODE? DO THE

IF YOU CAN REPLACE THE TERM "REALTOR®" WITH THE WORD "MEMBER, THEN IT PASSES THE TEST.

WHAT MAKES AN AD MISLEADING?

- ONETHAT IDENTIFIES A SALES AGENT AS A BROKER
- ONE THAT IS INACCURATE IN ANY MATERIAL FACT OR REPRESENTATION
- ONE THAT DISPLAYS THE VALUE OF A PROPERTY, UNLESS BASED ON APPRAISAL ALSO DISCLOSED AND AVAILABLE UPON REQUEST
- A PROPERTY
- ONE THAT IMPLIES THE SALES AGENT IS RESPONSIBLE FOR THE OPERATION OF THE BROKERAGE
- SECTION 535.155(d) of the TEXAS REAL ESTATE COMMISSION RULES
